## Copyright Agreement

### WHEREAS

- (A) The Publisher is contracted to manage the Countryside Recreation Network ("the Network") and to publish the Countryside Recreation Journal ("the Journal") and the proceedings resulting from the Network's conferences ("the Conference Proceedings").
- (B) The Author has written an article for publication in the Journal/will present a paper to a Network Conference ..... [Name of conference and date(s)] *\*delete as appropriate* ("the Work").
- (C) The Publisher wishes to publish the Work in the Journal and/or as part of the Conference Proceedings and the Author has agreed to grant a licence to the Publisher.

### IT IS AGREED

- 1. The Author as beneficial owner hereby grants to the Publisher the non-exclusive right both to reproduce and/or distribute the Work throughout the world in printed, electronic or any other medium in the Journal or the Conference Proceedings where appropriate.
  - 1.1. It is agreed that this Licence includes the right to publish or adapt, subject to Paragraphs 3 and 4, the Work for use in conjunction with computer systems, including networks, and to publish imprinted, CD-ROM, microfiche, on-line, or in any other machine readable form.
- 2. The Publisher hereby undertakes to prepare for publication and publish the Work in the Journal and/or Conference Proceedings.
- 3. The Editors and Publisher of the Journal or Conference Proceedings are empowered to make such editorial changes as may be necessary to make the Work suitable for publication. The Publisher will make every effort to consult the Author if substantive changes are required.
- 4. The Author hereby asserts his/her Moral Right to be identified as Author of the Work under the terms of the Copyright Designs and Patents Act 1988.

5. The Author warrants that:
  - 5.1. the Work is the Author's original work;
  - 5.2. the Work contains no libellous or unlawful statements and that it in no way infringes the rights of others; and
  - 5.3. the Author as the owner of the copyright, is entitled to grant the Licence set out in this Agreement.
6. If material from other copyright work is included in the Work the Author shall identify such material to the Publisher and shall obtain all necessary written permissions from the copyright owners of such materials.
7. The Author will indemnify the Publisher against any loss, injury or expense arising out of any breach of the warranties under Paragraphs 5 and 6.
8. In the event that Sheffield Hallam University ceases to be contracted to manage the Network and to publish the Journal and conference Proceedings the rights under this licence may be assigned to the Publisher's successor.
